INSTRUCTIONS AND APPLICATION

Scholarships of \$500 will be awarded.

Applicants must meet the following criteria:

- Must be a child of a Tri-County Electric member or live in a home served by Tri-County Electric or attend high school in our service territory (Charles B. Aycock, Eastern Wayne, Rosewood, Southern Wayne, Spring Creek, East Duplin, James Kenan, North Duplin, North Lenoir, or South Lenoir).
- Must be a high school graduating senior.
- Must pursue a regular four-year undergraduate course leading to a baccalaureate degree.
- Must plan to attend an accredited four-year college or university.

Scholarships of \$250 will be awarded.

Applicants must meet the following criteria:

- Must be a child of a Tri-County Electric member or live in a home served by Tri- County Electric or attend a high school in our service territory. (Charles B. Aycock, Eastern Wayne, Rosewood, Southern Wayne, Spring Creek, East Duplin, James Kenan, North Duplin, North Lenoir, or South Lenoir)
- Must be a high school graduating senior.
- Must pursue a regular course of study at a junior college, community college, vocational or technical college.

Information Requirements

Applicants must provide the following:

- Attached completed application
- Transcript from high school
- Short essay (at least 500 words) that describes the student's career goals and how they intend to achieve them, the student's involvement in local clubs, school and community activities, and explain why they believe they should receive the scholarship.
- Two letters of recommendation (thoughtful and original observations)

Selection Procedure

Selection is made by a Scholarship Committee made up of judges selected by Tri-County Electric Membership Corporation. Applicants must be willing to be interviewed by the committee, if necessary. Applicant must attend banquet on Sunday, May 7, 2017 at 6:00 PM to receive the scholarship. Decisions made by this committee shall be final.

Selection is determined based on the following criteria:

- 1. Scholastic achievement 60 percent
- 2. Extracurricular activities 30 percent
- 3. Need 10 percent

Deadline

Deadline for completed applications and supporting materials is March 31, 2017.

Tri-County will not accept late entries. Applications are available from Tri-County Electric or from your high school guidance counselor's office.
